

**SCOTT COUNTY FISCAL COURT
ORDINANCE NO. 22 - 10**

**AN ORDINANCE RELATING TO SPEED
LIMITS IN MALLARD POINT SUBDIVISION**

WHEREAS, Mallard Point Subdivision is a developed, residential area in Scott County;
and

WHEREAS, in the interest of public safety, certain regulations are required for the operation of automobile vehicle traffic in Scott County; and

WHEREAS, pursuant to KRS 67.083, the Scott County Fiscal Court has the authority to enact ordinances regarding the provision of streets and roads and enforcement of traffic regulations; and

WHEREAS, pursuant to KRS 189.390(5)(a), Scott County may by ordinance establish speed limits within its own jurisdiction; and

WHEREAS, due to the winding, curving, and steep nature of the county roads located in the Mallard Point Subdivision, in the interest of public safety, and as requested by residents of Mallard Point Subdivision, it is prudent to establish a speed-limit in Mallard Point Subdivision lower than the default speed-limit of 35 miles per hour in residential districts;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Fiscal Court for Scott County, Kentucky, that:

1. The speed limit for motor vehicles on all roads located within Mallard Point Subdivision shall be twenty-five (25) miles per hour. These roads are: Mallard Point Drive, Broadbill Court, Ringbill Court, Spoonbill Court, Drake Lane, Bluewing Court, Whitewing Court, Quandy Court, Whistler Court, Widgeon Way, Widgeon Court, Pinnacle Point, Mallard Point Court, Blue Bill Court, Bluffhead Court, Goldeneye Court, Redwing Court, Black

Duck Drive, Sheldrake Court, Blackberry Ridge Court, Shoveler Court, Merganser Court, Greenwing Court, Teal Court, Doe Court, Pintail Court, Falcon Court, Wooduck Lane, Eider Court, Brant Court, Canvasback Court, and additional roads as may be added to Mallard Point subdivision.

2. Signs shall be conspicuously posted by the road department in the Mallard Point Subdivision to provide notice of this speed limit.
3. All peace officers shall have the authority to enforce this speed limit consistent with the provisions of Kentucky law.
4. This ordinance shall take effect immediately upon passage and publication.
